WHICH DATA ARE WE STORING?

We store the following data of our members:

- Remarks by a member about his/her connection to PEKING (voluntary)

WHAT IS THE PURPOSE OF THE DATA PROCESSING / THE WEB PAGES OF OUR MEMBER SECTION?

The processing of the stored data complies with furthering the purpose of our Association as laid out in § 2 of our statutes, in particular "the preservation and operation of the four-masted barque PEKING at her berth in Hamburg, in order to preserve her as a cultural object of national importance and to make her accessible to the public as a museum ship in a suitable manner."

By using the contact data as well as the information entered by the members voluntarily, the Association's representatives, and the members among themselves can communicate with each other regarding ways to carry out the Association's purpose and organizing the Association's activities the membership administration and support as well as statutory formalities, duties resulting from being a member, especially the payment of membership fees.

HOW IS THE MEMBER DATA PROTECTED?

The transfer of data within our websites is encrypted (https protocol). Access to the website is protected by passwords (individual per member). Contact data may only be used for the communication with members, it is mandatory. Any additional information is voluntary. Our websites provide choices which allow each member to decide which data should be visible to other members and on the internet. The data will not be made available to third parties who are not members of the Association.

WHO ADMINISTERS THE DATA AND IS RESPONSIBLE?

Each member of the Association can access and review his/her data on the internet by himself/herself and change/delete it. The Association's board determines and assigns the responsibility to those in individuals who are responsible for the administration of the data. These members can be reached at datenpflege@peking-freunde.de.

Every member has the right to request information about any personal data concerning him/her and, if necessary, to correct or delete it.

For the sake of good order, we point out that it is impossible to exclude any security gaps or leaks in the data transmission via the internet (e.g. when communicating by e-mail).
